# Legal and Public Affairs Update – Provider Status

I wanted to use this opportunity to talk about provider status. This has been the hot topic on the monthly legislative affairs call for the state affiliates. To recap last year H.R. 4190 was introduced in the House of Representatives. On January 28<sup>th</sup> of 2015 this bill was reintroduced by Representatives Brett Guthrie (R-KY.), G.K. Butterfield (D-NC), Todd Young (R-IN.), and Ron Kind (D-WI) as H.R. 592 which is now known as the “Pharmacy and Medically Underserved Areas Enhancement Act”. Here is the language:

114th CONGRESS

1st Session

H. R. 592

IN THE HOUSE OF REPRESENTATIVES

January 28, 2015

Mr. Guthrie (for himself, Mr. Butterfield, Mr. Young of Indiana, and Mr. Kind) introduced the following bill; which was referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

### A BILL

To amend title XVIII of the Social Security Act to provide for coverage under the Medicare program of pharmacist services.

1. Short title

This Act may be cited as the Pharmacy and Medically Underserved Areas Enhancement Act.

2. Medicare coverage of pharmacist services

(a) Coverage—

Section 1861(s)(2) of the Social Security Act (42 U.S.C. 1395x(s)(2)) is amended—

(1) by striking and at the end of subparagraph (EE);

(2) by adding and at the end of subparagraph (FF); and

(3) by inserting after subparagraph (FF) the following new subparagraph:

(GG) pharmacist services furnished by a pharmacist, as licensed by State law, individually or on behalf of a pharmacy provider—

(i) which the pharmacist is legally authorized to perform in the State in which the individual performs such services;

(ii) as would otherwise be covered under this part if furnished by a physician, or as an incident to a physician’s service; and

(iii) in a setting located in a health professional shortage area (as defined in section 332(a)(1)(A) of the Public Health Service Act), medically underserved area, or medically underserved population (as defined in section 330(b)(3) of such Act);

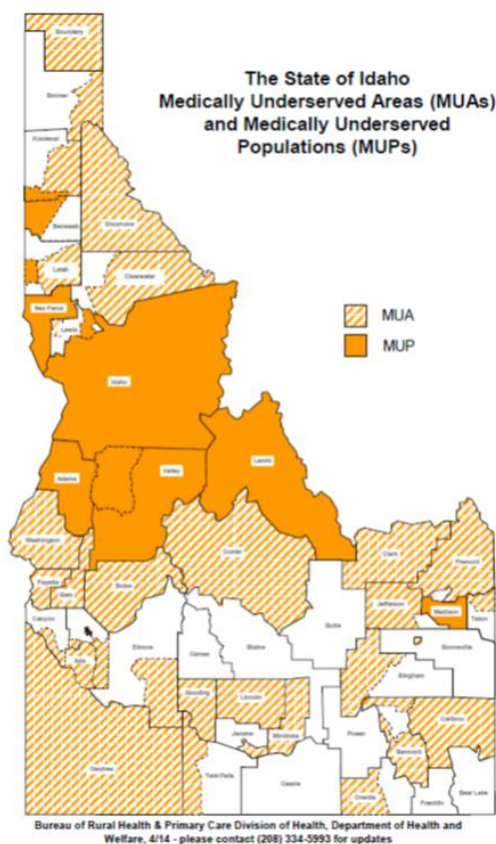
- (b) Payment  
Section 1833(a)(1) of the Social Security Act (42 U.S.C. 1395l(a)(1)) is amended—
- (1) by striking and (Z) and inserting (Z); and
  - (2) by inserting before the semicolon at the end the following: , and (AA) with respect to pharmacist services (as defined in section 1861(s)(2)(GG)), the amounts paid shall be equal to 80 percent of the lesser of the actual charge or 85 percent of the fee schedule amount provided under section 1848 if such services had been furnished by a physician.
- (c) Effective date; Pharmacist specific codes
- (1) Effective date  
The amendments made by subsections (a) and (b) shall apply with respect to services furnished on or after January 1, 2016.
  - (2) Pharmacist specific codes  
The Secretary of Health and Human Services shall develop pharmacist specific codes, as necessary, under the physician fee schedule under section 1848 of the Social Security Act (42 U.S.C. 1395w-4).

A bill with the same language was introduced in the Senate on January 29<sup>th</sup> of 2015 as S. 314 by Senators Chuck Grassley (R-IA.), Robert P. Casey Jr. (D-PA.), Mark Kirk (R-IL.), and Sherrod Brown (D-OH.). Both bills can be viewed at:

**Currently there are 113 co-sponsors for H. R. 592 and 13 co-sponsors for S. 314. Idaho is not on this list.**

At this meeting they joined 22 other state delegates representing Arizona, California, Colorado, Nebraska, New Mexico, Nevada, Oklahoma, Oregon, Texas and Wyoming. All of the national delegates will meet when the House convenes in June during the ASHP Summer Meeting in Denver.

Each state representative **read** and **reviewed 33 new or revised policies** that will be voted on June 9<sup>th</sup> to be included in ASHP policies that the organization lobbies for on Capitol Hill. ## Operation Haiti

*(Editor's note: Last spring ISHP members Whitney Hurt and Tyler Osgood traveled to Haiti on a medical mission with Humanitize Expeditions. They graciously agreed to share their story with ISHP)*



Humanitize Expeditions is a humanitarian organization that coordinates a number of projects each year focusing on teaching, building homes, and providing medical care in both Haiti and Guatemala. Through our traveling medical clinics we were able to treat hundreds of Haitian natives with a large variety of different medical conditions ranging from poor vision fixed with something as simple as a pair of glasses to complicated and potentially life threatening infections.

So what was it that pharmacy brought to the table? The first level of pharmacy involvement began months prior to our trip with our participation in our formulary development. With limited funds and a broad and atypical array of anticipated diseases this was a particularly difficult task. Upon arrival in Haiti pharmacy was able to assist in medication organization and therapeutic planning as it related to specific anticipated clinical scenarios. During clinics we were able to offer consultation as it related to pediatric dosing, medication selection in complicated disease states, assistance with differential diagnosis, and alternative therapies in light of diminishing supplies. We all supported each other in the clinic and worked collaboratively to ensure best patient care.



“Haiti. A word and place that brings back so many memories. Memories of an entirely different place full of people just like you and I. Memories of a group of people who came together, made an impact on so many lives through their knowledge in healthcare and were also impacted by the gratitude of families dealing with simple muscle pain to festering skin infections. Travelling to Haiti with the team opened my eyes to the difference a pharmacist can make alongside others to give care to those who might not ever see it otherwise. The biggest impression left on me was the children who when first approached appeared to be alone and sick, but then became so animated and full of laughter. They had so “little” but showed me how much we truly have in life when we just take the time to experience it with each other. I will forever take this experienced enthusiasm into my future practice as a pharmacist whether interacting with other healthcare professionals, young children, or my middle aged patient with hypertension. If presented with the opportunity to be part of something like this, I whole-heartedly encourage you to seize it!”

## 2015 POISON PREVENTION WEEK (PPW) SUMMARY



As in years past, Idaho pharmacists, students, and technicians collaborated with personnel from the State of Idaho to help educate the public about poison prevention and celebrate National Poison Prevention Week (March 15-21). The recurring theme for this important event is *“Children Act Fast...So Do Poisons!”* Our partners this year were **2-1-1 Idaho CareLine** and Idaho Injury Prevention, Division of Public Health, Idaho Department of Health and Welfare, and The Nebraska Regional Poison Center, Omaha, Nebraska.

In early March, postcards were mailed to all Idaho Registered Pharmacists and Certified Pharmacy Technicians and ISU Pharmacy students were e-mailed with the same information. These groups were encouraged to provide poison prevention lectures to third graders statewide. In addition, postcards were mailed to daycares, elementary schools (third grade), WIC clinics, and Head Start programs alerting them that poison prevention information was available from the 2-1-1 Idaho CareLine website.

The 2-1-1 Idaho CareLine website and selected documents available on the website were updated to simplify ordering and downloading poison prevention materials. The 2015 National Poison Prevention Week poster contest guidelines and artwork release form were also posted on the 2-1-1 website. We are hopeful that Idaho students will submit their artwork to be considered for a future National Poison Prevention Week poster. Idaho Injury Prevention (via Maternal and Child Health Programs) and the Nebraska Regional Poison Center worked more closely this year and they were able to send out press releases and various materials to all interested parties.

Thank you to all the people who once again made this a very successful campaign.

### Health-Systems Speakers

On April 20, 2015 we heard from a local residency director (Dr. Paul Black) and PGY2 resident (Dr. Elaine Nguyen). Dr. Black spoke to the SSHP on the future of postgraduate training and what students can expect when they move into a PGY1 position. Dr. Nguyen discussed CVs and showed a few examples of her own that scored high when she was applying for residency. Soup, salad and sandwiches were provided for all in attendance with the grant money. At another meeting we heard from a member of the ISHP Board on the Pharmacy Practice Model Initiative and its status among Idaho hospitals.



### ASHP Strategic Plan Project

A relationship was started with the Boise Senior Center and a Medication List form was created to fit our patients' needs. Money from the grant was used to print flyers announcing the event, as well as 50 copies of the Medication List form. Four students and our ASHP pharmacist mentor signed up to represent ISU-SSHP at the event. Each student met with patients and reviewed their medications in order to create a "Home Health List". By helping these people better understand the details of their medications, hopefully we are able to help prevent some adverse drug events. However, in the case that the patient does have to enter the healthcare system now they will be prepared to deliver a complete list of conditions and medications to help inform their provider.
